VSCC is governed by a twenty-five member Board of Directors. The Board is composed of representatives of various regions of the county, thirteen lodging seats and a cross-section of representatives of businesses, cultural, governmental and organizations with affiliation to the travel and tourism industry. Responsibilities include participation in the governance of the organization, general advocacy for the tourism industry, and active participation at board meetings held six times per year. Meetings are held at 3:00 p.m. the last Wednesdays of January, March, May, July, and September. The November/December meeting dates vary due to the holidays.

Both the Nomination Form and Nomination Application must be completed and submitted to make a nomination valid. Individuals may nominate themselves.
