Santa Cruz County Film Commission Information on Drone Filming

The Santa Cruz County Film Commission, a department within Visit Santa Cruz County is a referral agency for commercial film productions taking place within the region. Please see the requirements below for filming with a drone in the various municipalities and other areas within Santa Cruz County. Should you need additional information, please reach out to the jurisdiction directly.

Monterey Bay National Marine Sanctuary

The Monterey Bay National Marine Sanctuary (MBNMS) is the second largest federally protected body of water in the United States. Therefore, responsible filming practices must be observed when considering projects over and near the water. Obtaining permits for prohibited activities in the Sanctuary is part of this process.

The MBNMS and the California Department of Fish and Wildlife prohibit aerial flights under 1,000 feet along Santa Cruz County's coastline due to the sensitivity of the marine and bird life in the area. Failure to maintain a minimum altitude of 1,000 feet above ground level above any such zone is presumed to disturb marine mammals or seabirds. However, permits may be obtained in some cases.

Common activities that require a MBNMS permit and approval include but are not limited to: filming operations, overflights, flying below 1000-feet within a NOAA Regulated Overflight Zone and others. This is not a complete list so carefully evaluate your proposed activity, or contact permitting staff for more detailed information.

MBNMS processes permits for use of an Unmanned Aircraft Systems (UAS). For further information, see MBNMS's Aircraft, Model Aircraft & Drones web page.

City of Santa Cruz

The City of Santa Cruz requires permits for commercial activities, including activities for promotional purposes. Currently, private use of drones for recreational purposes does not require a permit.

Depending on the proposal other conditions may apply at the time of final permit issuance. More information about filming in the City of Santa Cruz can be found here.

The following documentation is required to film within the City of Santa Cruz using a drone:

- 1. A completed <u>film permit application</u> submitted no less than three (3) days prior to production date
- 2. Payment of all fees at time of application
- 3. A map of route or layout of all locations for intended use
- 4. Use of drones, Unmanned Aircraft Systems (UAS) for filming requires FAA certification/licenses for all pilots or operators
- 5. Proof of current licenses/certification must be provided to the event permit office prior to filming
- 6. \$2,000,000 insurance certificate, with an endorsement, must be submitted and approved prior to filming

City of Watsonville

The City of Watsonville requires a permit for filming, however there are no ordinance in place for the use of drones for filming beyond current FAA requirements. More information can be found here.

There are FAA specific requirements in place for flying UAS (Drones) within the airport influence area (AIA). The AIA encompasses land within two miles of the boundaries of the Watsonville Municipal Airport. An automated process can be <u>found here</u>. Adherence to the requested action and notification is required.

The Watsonville Municipal Airport requires a permit be issued if there is commercial (for profit) filming on the field. Click here for more information.

The County of Santa Cruz requires a permit for filming, however there are no ordinances in place for the use of drones for filming beyond current FAA requirements. Santa Cruz Port District - Santa Cruz Harbor

The Port District does not have any ordinances permitting or prohibiting drones from flying over the harbor or harbor beach. UC Santa Cruz

The UCSC campus is within five nautical miles of the Dominican Hospital helipad and drone pilots should always be aware of helicopter traffic. FAA regulations prohibit the use of drones for non-recreational purposes within five nautical miles of an airport, or approximately 5.7 land miles.

The general FAA drone flight guidelines apply to filming with a drone at UCSC:

- Fly at or below 400 ft
- Keep your UAS within sight
- Never fly near other aircraft, especially near airports
- Never fly over groups of people and always respect the privacy of others
- Never fly over stadiums or sports events
- Never fly near emergency response efforts such as fires
- Never fly under the influence
- Be aware of airspace requirements

Due to the dense tree canopy of upper campus, most drone flights are conducted above the lower campus open fields.

All drone flights should be <u>registered through the UC portal</u>. The University of California, Office of the President, operates the drone program and establishes the rules governing the use of drones on campuses.
